

Toxicity Profile

PF-5052 fluid is non-irritating to the skin. The product also demonstrates very low acute and sub-chronic inhalation toxicity. A Material Toxicity Summary Sheet (MTSS) is available upon request.

Safety and Handling

PF-5052 fluid is nonflammable, and is highly resistant to thermal breakdown and hydrolysis in storage and during use. Recommended handling procedures are provided in the Material Safety Data Sheet, which is available upon request.

Environmental Properties

PF-5052 fluid has zero ozone depletion potential. The material is exempt from the U.S. EPA and most State definitions of a volatile organic compound (VOC), and does not contribute to ground-level smog formation.

PF-5052 fluid, a perfluorocarbon (PFC), has a high global warming potential and a long atmospheric lifetime. As such, it should be carefully managed so as to minimize emissions.

3M recommends that users of PF-5052 fluid further limit emissions by employing good conservation practices, and by implementing recovery, recycling and/or proper disposal procedures. 3M offers a program in the U.S. for used fluid return. Guidelines for the safe handling and use of this 3M product are provided in the Material Safety Data Sheet.
