Dear Customer,

The purpose of this letter is to inform you about our approach regarding REACH regulation.

### **Registration process**

In accordance with the regulation (CE) n°1907/2006, substances manufactured or imported in more than 100t/year have been registered on 2013, May 31st. To make this registration, for each substance, producers and importers are together in a forum, named "SIEF"<sup>1</sup>, in charge of the redaction of the registration dossier.

From now on, substances manufactured or imported in more than 1t/year must be registered before 2018, May 31st.

We confirm to you that we put a process in place in order to be in relation with each of our suppliers and to keep ourselves informed about registration progress concerning supplied substances.

### **Substances of potential concern**

REACH Regulation plans an authorization process (Annex 14's substances) and a restriction process (annex 17's substances).

Then, ECHA updates very regularly lists of substances potentially concerned by these processes.

In order to put on the market, only products without substances listed on annex 14 and 17, we inform you that we check regularly these lists.

### **Communication on the supply chain**

Only communication tool planned by REACH Regulation, the Safety Data Sheets of our products are available on [www.quickfds.com](http://www.quickfds.com) (free access).

**If applicable**, you will find the registration numbers and the covered exposure scenario for the substances or the classification on the list of the concerned substances (SVHC<sup>2</sup>).

For the mixtures put on the market, INVENTEC has made the choice to directly integrate in the SDS main part (section 1 to 16) the relevant information from exposure scenario of substances contained in the mixture (in accordance to the ECHA guidance on MSDS compilation).

In the event of INVENTEC delivers to you non classified substances or mixtures, or under pressure liquefied gas classified 2.5 in accordance with CLP Regulation and with no other hazards for health or environment, the SDS won't have exposure scenario in appendix (Regulation (UE) N°252/2011).
