**FLUOROLINK® A10-P, FLUOROLINK® AD1700, FLUOROLINK® E10H, FLUOROLINK® F10, FLUOROLINK® MD700, FLUOROLINK® P 54, FLUOROLINK® S10** and **FOMBLIN® FE 20 C** are polymers or are made by polymers according to the REACH regulation therefore they are exempted from registration and evaluation (art.2.9, EC 1907/2006).
